

CHURCH ON THE HILL LIABILITY RELEASE / HOLD HARMLESS WAIVER

COTH Missions

I, the undersigned, desire to travel to one or more foreign locations in cooperation with Church on the Hill for the purpose of participating in one or more campaigns designated to travel across state or country borders. On behalf of myself, my heirs, representative and assigns, I hereby release and discharge Church on the Hill, its members, employees, officers, directors, representatives, and participating churches (including the churches we will be working with on the field) from and against any and all claims for any and all injuries (including death), losses or damages (including personal property loss or theft) I might have or sustain on, or in any way relating to such campaign, any travel or stay to, in and from any foreign locations, whether before, during or after a campaign or otherwise.

In exchange for attendance and participation during said campaign, I agree to protect, defend and hold Church on the Hill harmless from, and against any and all claims, demands, causes of actions of every kind and character, such as: losses, costs, expenses (including legal fees), and damages of every kind and character for injury or death and property damage sustained or alleged to have been sustained arising out of, or relation to, or incident to my action in this campaign.

I give Church on the Hill, and its representatives, authority to request and authorize medical and/or hospital treatment for my benefit in the event of any injury or sickness sustained by me while on any such travel, stay or other activity relating to travel to foreign locations (state or country). I agree to pay for all such treatment and to reimburse Church on the Hill for all costs and expenses incurred for treatment.

I understand that any and all deposits and payments provided to Church on the Hill in my name for the aforementioned campaign are nonrefundable, but may be transferable. Should I be unable to attend the campaign, I understand that these funds will be forfeited unless I am able to provide a replacement for my position which is approved by my participating church and/or Church on the Hill. In the case that I find a suitable replacement for my position, I understand that additional fees may be incurred in order to transfer my position to the approved person.

I understand that Church on the Hill has the right to terminate my trip and send me home at any time without providing any refund of finances should I violate the trip rules and/or engage in any form of illegal, immoral, or unscriptural conduct. I agree to release Church on the Hill from any financial responsibility for such disciplinary action. I also understand that I will be held financially liable for any damage, fines, penalties, or other settlements resulting from such activity. And, I agree to pay all additional fees and fines incurred by Church on the Hill for my transportation, food and lodging resulting from my early return to my home country and city.
